Acknowledgement of Rules of the 2024/25 Innovation Award

- 1. To be eligible for entry, participants are required to fully complete the Development Bank of Namibia (DBN) Innovation Award entry form. Additional sheets of paper may be used if necessary. Participants must also complete and sign the acknowledgement of the Award rules.
- 2. The entry form must be accompanied by all necessary documents and meet the minimum requirements outlined in the entry form.
- 3. The selected top four finalists will be required to make a presentation to the panel of judges.
- 4. Finalists may be required to demonstrate working prototypes to the panel of judges.
- 5. The top three finalists will be required to provide certified copies of documents pertaining to the entry and its promoters.
- 6. Certified copies of documents will not be returned, nor will originals. It is incumbent on the entrant to ensure that documents are certified copies.
- 7. Entrants agree to indemnify and release DBN from any loss, cost, expense, or liability, whether legal or otherwise, that may arise as a result of their participation in the Award.
- 8. By entering the Award, entrants certify that ownership of patents or intellectual property or copyrighted material relevant to the entry vests in them, or that they are entitled to use third-party patents or registered intellectual property or copyrighted material.
- 9. First party patents or registered intellectual property or copyrighted material vesting in the entrant remain the property of the entrant.
- 10. Should the Bank receive suitable submissions, one entry will win the Award, and two runners-up will be identified.
- 11. The winners and the two runners-up will be required to complete and sign the DBN Anti-fraud declaration and the DBN indemnity form.

- 12. The winners and two runners-up will be identified and photographed for publicity purposes, and project descriptions and merits will be publicized.
- 13. The winner and the two runners-ups, or their representatives, will be required to attend the 2024/25 Good Business Awards Ceremony in Windhoek, at a date to be determined by DBN.
- 14. DBN employees, as well as their immediate family members, associates, and suppliers of DBN are not eligible to enter.
- 15. The decision of the judges is final, and no correspondence will be entered into.
- 16. The Award monies must be applied to the benefit of the project entered into the Award.
- 17. The closing time and date for entries is 16h00 on 10 February 2025.
- 18. Entries must be submitted in clearly marked and sealed envelopes to the physical offices of DBN in Windhoek, Ongwediva, Rundu or Walvis Bay.
- 19. Prospective entrants indemnify DBN from non-receipt or faulty transmission of entries and all associated components.
- 20. Failure to adhere to these rules will result in automatic disqualification from the Award and all benefits associated therewith.
- 21. DBN reserves the right not to make any award. The Development Bank of Namibia reserves the right to withhold the granting of any award.
